Section 3a – Psychic Detective

- If you have ever lost a loved one, finding closure is difficult enough. Imagine how miserably painful it must be to lose a loved one who has disappeared. Closure cannot be possible until the mystery of their disappearance is solved.
- This Section will go into how we can psychically investigate individuals who are missing.
- Psychic Detective work can include mediumship if the missing person has deceased. However, if the missing person has not deceased, being able to connect to the consciousness of another can be helpful.

Psychic Detective Story -1

- Here is a cute and true psychic detective story about finding the remains of a missing kitten. The story reveals the basic technique, which is connecting to the consciousness of someone alive or dead.
- In this story connecting to the consciousness of the missing kitten was not helpful. However, connecting to the consciousness of my friend did reveal much validating information leading us finally to discover the whereabouts of the missing kitten.

Example 1: The Missing Kitten (True Story)

- My friend could not find a missing kitten.
- She was fostering several cats at the time.
- Try as she might she was unable to find the runt of the litter.
- Called me for help.
- I connected to my friend's consciousness using LOVE formula. Let go in meditation, Open in prayer, Vibration alignment and Entirely receive.
- Then I followed what I saw in my friend's mind the night the kitten disappeared, getting verification to ensure I was on the right trail of energy.

What I Saw

- My friend left her apartment to go to a local watering hole. (Verified.)
- Played some pool. (Verified.)
- Went home. (I could actually see everything and it was verified.)
- After going into her apartment, I saw the kitten crawl under a big padded couch.
- The torn lining under the couch allowed the kitten to crawl into it and hide.
- The kitten felt sick like it could not breathe.
- It died inside the lining.
- My friend went immediately to find the kitten under the couch in the lining.
- It was there.

Example 2:

Murder South America

- This is a good example of how mediumship can be used in psychic detective work.
- Each Psychic Detective works differently as does each medium, so the way the material presents here is how I work.
- I experience the consciousness of the loved one in spirit as if they are talking directly to me.
- As mentioned in Chapter One my first experience doing mediumship was done by channeling the deceased father of two sisters from New York. They wanted me to recount what happened the night their father was murdered at a family owned bar in South America.

Murder: South America, Cont'd

- This is his response through me.
- "I can remember it. I was not feeling that well that evening when I got home but I heard a noise in the store so went inside without realizing what was happening. Then all of sudden out of the back came this man, Enid's boyfriend.
- Enid was already in the front of the store and looked startled. He immediately took it upon himself to accuse me of being after his girlfriend to cover for the hostility he was about to put on me. 'She is his girlfriend,' he says, and 'she is not going to go with you or any other man.'
- Enid looked shocked and even embarrassed at this. She knew it was ridiculous but was scared for she also knew that her boyfriend was a man to be reckoned with. He was dangerous.

Murder: South America, Cont'd

- Anyway, they came at me and started to hit and slap me. I tried to struggle and struggle but I could not get away. One thing led to another and they got more and more violent, tying me up and so on. I cannot remember exactly how everything happened but finally when my head was hit, it was over.
- I must say that I learned how to get out of my body. I tried at one point to do that so I would not suffer. It was over I knew, so I tried to release myself from feeling what was happening. I was able to do this and avoided much of the suffering.

Murder: South America, Cont'd

- It happened as soon as I passed out. I was able to step away from the suffering and relieve myself of it. Finally they stopped when they saw I would not move anymore. It was a tragedy to be sure.
- But as I said earlier this was the way it was supposed to be. This was my life's lesson. I had a probable exit from my life here and in an ironic way. For all my years of being with women I was accused this one last time when I was totally innocent. Cosmic justice."

Murder: South America, Cont'd Validation

- His daughters did verify that he had learned how to leave his body using mind body techniques.
- As well, he had extra marital affairs and they had an extended family of half brothers and sisters.

Noreen Renier

- Web: NoreenRenier.com.
- Former highlighted medium on TLC's "Psychic Detective" show.
- In 1981, when Psychic Investigator Noreen Renier first lectured at the FBI Academy in Quantico, Virginia, her work with police detectives was considered controversial.
- Now, highly respected psychic detective who has worked on over 600 unsolved cases with city, county, and state Law Enforcement Agencies in 38 states and 6 foreign countries.
- "Noreen never could have known this stuff beforehand and she was so accurate it was chilling." — R. Krolak (Retired Lt. Commander)
- "...She helped to locate a plane containing the body of a relative of an <u>FBI agent.</u>" Robert Ressler (Ex-FBI)

How Noreen Works

1. She likes to work with little information. The less she knows about the victim the better. (This is true of doing psychic mediumship as well. You must not allow your "sitter" to provide any information except for validation as you build evidence.)

2. She usually will work with psychometry. This means she will touch a piece of clothing or object owned by the missing person and begin to feel and see images.

a. Psychometry is a way to connect with energy. It is NOT mediumship. Mediumship is telepathy.

Noreen Renier

- The first thing she does is find information about the victim which the police can validate, such as what the victim looked like, where he or she was last seen or other simple facts. If the facts are correct she will move to the next phase of the investigation.
- This is how you should work when you read for clients. Without being provided any information begin to receive information for validation.
- If the information is validated then you know you have a confirmed connection and your energy is properly aligned with the receiving subject.
- If it is not validated, go back, reestablish connection with the loved one in spirit and start again. Continue to do this as many times as you need until you have made validated contact.

Noreen Renier

- Fascinatingly, Noreen instructs the police to ask her questions in a certain way. For example instead of saying, "Where does a suspect live?" she suggests it is better to ask, "Stand in front of the house and walk toward it. What do you see?" This allows Noreen to receive information using the skills she has, most obviously, remote viewing.
- She uses all five of her senses when she receives information. She might hear, see, smell, etc.
- She reminds her visitors she is not 100% accurate, nor can she be equally effective on all cases.

Keep that in mind for your own work.

Psychic Detective Annette Martin

- Annette Martin (<u>http://www.closure4u.com/</u>), similar to Noreen does psychometry to solve crimes. However, she will look at pictures as well of the victim, whereas, Noreen prefers to describe the victim during the initial stages of the investigation to check energy connection in solving the case.
- Annette is a dowser as well. This means she will use a pendulum over a map attempting to track down a missing person.
- Annette can pick up medications, health issues, and other physical attributes of the victim or suspect to help solve the case.

Annette Martin, Cont'd

- The following was taken from Annette's site about how she works to solve a criminal case.
- Case Review begins with a package that includes the following:
 - An original photograph of missing person (most recent photo), not a photocopy or scan. Or photo of building, if this is an arson or espionage case. The less the photo is handled the better the results Annette will have with the photo.
 - A copy of any bulletins or newspaper articles that were issued.
 - They do not need any confidential police reports or evidence information. They will not compromise the police investigation nor intrude in any area of their case.

Annette Martin, Cont'd

- A map or maps of the area where the disappearance occurred, or when the investigation is taking place.
- If a body has been found in a wooded area, aerial maps are most helpful in locating dirt roads.
- If the incident occurred within a residential neighborhood of a particular city, they would want that city map, marked where it had occurred and where the victim had lived in that city.
- Also a larger map of the adjacent areas or even a State map, in the event that Annette perceived travel by the suspect. This would preclude having to stop any particular session and then having to acquire an additional map.

Annette Martin Cont'd

- If you have any personal articles belonging to the victim such as a watch, ring, wallet, eyeglasses, etc., Annette can use that along with the photo.
- This is a process called psychometry.
- Annette uses this type of item as a backup to the energy field received from the photo.

Psychic Energy Vs. Telepathy

- This section is meant as a way to widen your understanding of mediumship.
- Psychic detective work might or might not use mediumship as a tool.
- I feel the best psychic detectives get information from the deceased, as well as, energy left behind.
- At times a medium may confuse reading energy instead of using telepathy to get information. At times it is difficult to see the difference.
- Mediumship is, however, direct communication with the consciousness of the deceased.

Mediumship Secret: Dreamy

- Being able to move from thinking to dreamy is a secret to successful psychic work, particularly mediumship.
- Let's practice getting dreamy right now.
- Think of a problem you have. Really focus on it. Try to solve it.
- Now just let go and get dreamy. Clear your head. Imagine you are floating on a cloud high up in heaven. Just relax and float.
- While you are doing this, see if any ideas pop in. Write them down. This is your psychic mind delivering answers.
- HOW DID THIS FEEL?
- This is a skill you should use all the time in your work.

Exercises – Psychic Detective

- 1. Prepare for next exercises with LOVE formula.
 - 1. Let go in meditation. Class deep breathe abdominally 3 times.
 - 2. Open in prayer. All beings of highest light and love please provide messages of highest accuracy in love, light and protected space. Please disconnect at end automatically. And so it is.
 - 3. Vibration alignment. Imagine energy blending with subject(s) of reading.
 - 4. Entirely receive what comes in.

Get DREAMY, FEEL EMPATHY as you focus on picture at right. Ask this missing person for answers to the following questions of what, when, where and how? Person: KAREN ADAMS from http://www.fbi.gov/wanted/kidnap

Dead or alive? Date last seen? Appearance description? Location last seen? Car? Last observed? Background: Work, marital status, children, pets? Games she played? Where did she live? Were you kidnapped? Did you have any health problems? Did you have any money problems? Were you abducted or did you go peacefully with your abductor? Did you know your abductor or was he or she a stranger to you? Were you buried? Where?

ANSWERS: Karen Adams

- Last seen March 11, 2007. •
- Last seen? Karen S. Adams was last seen at a popular gambling location in Hancock County, West Virginia. On the evening of March 11, 2007, Mountaineer Casino Racetrack and Resort to play bingo.
- Car? Adams drove her red/maroon, four-door, 2005 Suzuki Forenza sedan with Pennsylvania license plate ETD5587 just across the Pennsylvania state line to the Mountaineer Casino Racetrack and Resort to play bingo.
- Time left? She was seen there and was known to have left the bingo area around 11 p.m. that evening, possibly headed to the gaming side of the resort to play the slot machines.
- Last observed? She was observed on surveillance video at approximately 3 a.m. on ۲ the morning of March 12, 2007, leaving the gambling complex and she has not been seen nor heard from since that time. Her car has also not been located.
- BACKGROUND? Work, marital status, children, pets? Adams worked at a local ۲ elementary school as a teacher's aide and at a local department store as a cashier clerk. She was not married, but did own a dog to which she was quite attached. GAMES? Adams enjoyed playing local bingo. LIVED? She lived in Independence Township, Pennsylvania, which is close to the West Virginia border.

ANSWERs: Karen Adams, Cont'd

- Now do a search on that person's name on the Internet. See if you can find any other information about their whereabouts to validate any thing else you received.
- Compare what you got to what you read online.
- Example: Karen Adams lived with her brother, would never leave her dog behind, etc. Found here: <u>http://betweenlifeanddeath.blogspot.com/2007/12/ka</u> <u>ren-adams-missing-from-independence.html</u>

Exercise, Cont'd

- You can do this exercise as many times as you please to further develop your psychic & mediumship skills. Even if the person you are receiving is not dead, receiving the information from another person telepathically dead or alive is a valuable tool for developing mediumship. As a matter of fact, it is the essence of it.
- NOTE: If you are not able to receive anything using these instructions, try using the tools you normally use to receive information psychically. Go back to chapter one and receive using your natural skills.
- There is no right or wrong way to receive information. There is only <u>right information</u>! So be flexible in the way you get your information.
- Move to next Section after you feel comfortable with what has been covered thus far.

Section 3b: Pet Mediumship

- Pet's come in from otherside.
- Just as lucid as humans. Like little children.
- Dog story. Client asked me to bring her dog from other side.
 - Showed me breed, what she passed from, how she felt about being put to sleep, some earth memories of how it felt to be with the neighbors dog and hang out together, where she is now.
 - She thought she was a Princess!

Pet Mediumship Exercise

- Get a partner with which to work.
 - In Class? Teacher assigns.
 - Working Alone? Find a friend or someone on Facebook Support Group, Soul Psychic Healer.
- Do LOVE formula if doing this exercise separately.
- Receive on your partner's pet. GET DREAMY then see what you get. Some ideas of what to get:
 - Dog, cat or what type of animal?
 - Appearance?
 - Names
 - Cause of passing
 - Personal message. Ex. How it felt about itself on earth or now in spirit. How did it feel about its passing? Does pet come in to visit?

More Mediumship

- Time allowing working with same partner bring in another pet or a human for this partner.
- Get DREAMY, then try to get:
 - Appearance
 - Names
 - Cause of passing
 - Relationship to sitter
 - Message of personal significance.

Homework

- Do the pet and human mediumship as many times as you can until this starts to get easy.
- Practice getting dreamy about problems in your life or when working with clients until answers come into your mind.
